FURTHER RESOLVED, in compliance with N.J.A.C.6:20-2A.10(e), the Board of Education certifies that, after review of the secretary's monthly financial report (appropriation section), to the best of its knowledge, no major account or fund has been over expended in violation of N.J.A.C.6:20-2A.10(a)(1), and that sufficient funds are available to meet the district's financial obligations for the remainder of the year.

D. The Superintendent recommends and I so move Board of Education of the Township of Green Brook approval of the disbursements for the following payroll period for the 2015-2016 school year:

E. The Superintendent recommends and I so move Board of Education of the Township of Green Brook approves the following resolution:

WHEREAS, pursuant to the provisions of N.J.A.C. 6A:23A-7.3 (b) the Green Brook Township Board shall establish, in the annual school budget, a maximum expenditure amount that may be allotted for such travel and expense reimbursements for the 2016-2017 school year;

BE IT RESOLVED, that the Green Brook Township Board of Education hereby establishes the school district travel maximum within the 2016-2017 tentative budget at a sum of \$75,000; and

BE IT FURTHER RESOLVED, that included in this amount is the maximum regular business travel amount of \$1,500 per employee; and

NOW, THEREFORE BE IT RESOLVED, that the School Business Administrator shall track and record these costs to insure that the maximum amounts are not exceeded.

F. The Superintendent recommends and I so move Board of Education of the Township of Green Brook approves the following resolution:

WHEREAS, the Green Brook Township Board of Education has the ability to use banked cap in the general fund tax levy to balance the 2016-2017 tentative budget; and

WHEREAS, the Board will be using \$185,151 from 2013-2014 in banked cap in order to balance the general fund for the 2016-2017 tentative budget, maintain existing programs, implement mandated programs, and remain in alignment with the district's strategic plan; and

WHEREAS, the 2016-2017 budget guidelines require the Board to formally adopt a resolution when using banked cap in the 2016-2017 tentative budget; and

WHEREAS, the district is going above the 2% tax levy cap with the additional tax levy bank cap of \$185,151.

NOW, THEREFORE BE IT RESOLVED, that the Board authorized the School Business Administrator to add funds to the general tax levy utilizing tax levy banked cap.

G. The Superintendent recommends and I so move Board of Education of the Township of Green Brook approves the following resolution:

WHEREAS, the 2016-2017 tentative budget includes sufficient funds to implement the proposed planning process as described in the district's Annual Report pursuant to N.J.S.A. 18A and N.J.A.C Title 6 and 6A and to provide curriculum and instruction which will enable all students to achieve the Core Curriculum Content Standards;

BE IT RESOLVED, the Board of Education approves the 2016-2017 tentative budget in the amount of \$24,686,032 and authorizes its submission to the Executive County Superintendent of Schools for approval as follows:

BE IT FURTHER RESOLVED, that the tentative budget will be advertised in the Courier News newspaper in accordance with the form suggested by the State Department of Education and according to the law; and

NOW, BE IT FURTHER RESOLVED, that the Board of Education meeting be held on April 25, 2016 at 7:00 p.m. for the purpose of conducting a public hearing on the budget for the 2016-2017 school year.

H. The Superintendent recommends and I so move Board of Education of the Township of Green Brook approval of the following resolution:

WHEREAS, the Green Brook Board of Education ("Board") is the owner of Noble Field and the ITB Field (the "Fields") located at the Irene E. Feldkirchner School; and

WHEREAS, the Green Brook Little League Group, Inc. ("Little League") is a charter member of and operates under the direction of the Little League Baseball, Inc. and provide athletic opportunities for children of the Green Brook Township community during non-school hours; and

WHEREAS, the Board of Education uses the Fields as an integral part of its physical education, but does not use the Fields for school purposes when school is not in session after school hours and on weekends; and

WHEREAS, for more than a decade the Board of Education and the Little League have entered into various License Agreements whereby the Little League was permitted to install field lights and to utilize the Fields when they were not needed for school purposes; and

WHEREAS, the Little League also undertook certain maintenance and insurance obligations as a condition of the use of the Fields;

NOW THEREFORE BE IT RESOLVED, RESOLVED, that the Green Brook Board of Education hereby authorizes the License Agreement with the Green Brook Little League, Inc., for the period January 1, 2016 through December 31, 2016 with the option to renew for three additional one year periods which is attached hereto and incorporated by reference for an amount of One Dollar (\$1.00) per year and other valuable consideration; and be it

FURTHER RESOLVED, that the Board hereby determines that the Fields are not necessary for school purposes for the dates and times requested by the Little League as provided by the terms of the License Agreement and subject to Board Policy governing the annual use of school facilities; and be it

FURTHER RESOLVED, that the Board President is hereby authorized to execute the License Agreement between the parties.

I. The Superintendent recommends and I so move Board of Education of the Township of Green Brook approval to accept out-of-district tuition Student # 3167049017 from the Readington School District to attend the Green Brook Township School District's LEAD Program at the Green Brook Middle School effective April 4, 2016 through June 17, 2016, at a prorated amount of \$14,722.34.

- **J.** The Superintendent recommends and I so move Board of Education of the Township of Green Brook approval of Sara Vanek, Occupational Therapist, to complete Occupational Therapy Evaluations, at a cost of \$275.00 per evaluation, not to exceed \$550.00, for the 2015-2016 school year.

- **M.** The Superintendent recommends and I so move Board of Education of the Township of Green Brook approval of the Lakeview School audited tuition undercharge adjustment in the amount of \$1,999.20 for the 2013-2014 school year. The tentative tuition rate was \$88,454.10 and the audited actual tuition rate in accordance with the Department of Education N.J.A.C.6A:23A-18-2 (m) was \$90,453.30 for the 2013-2014 year.
- N. The Superintendent recommends and I so move Board of Education of the Township of Green Brook approval of the customer agreement with Frontline Technologies for Aesop one-time startup cost of \$4,500.00 and one year annual subscription of \$5,326.00 for staffing substitutes and tracking of employee hours worked to insure compliance with the Affordable Healthcare Act, total amount due after July 1, 2016 of \$9,826.00.
